



MUTUAL NON-DISCLOSURE AGREEMENT

Functions of the PARTNERSHIP and RIGHTS

6. **Pixelaar FZC LLC** will be providing an affiliate URL to the Author where they can track all their reference and earning statements as well as all necessary income related information.

7. Payment will be disbursed on the closing of each project on **Author** agreed payment withdrawal method.
8. Income tax will be subject to each company structure. Profit disbursement will be based on project value as it is in the term. No deduction or fess can't be adjusted from **Author's** income.
